  - One will be about taxation.

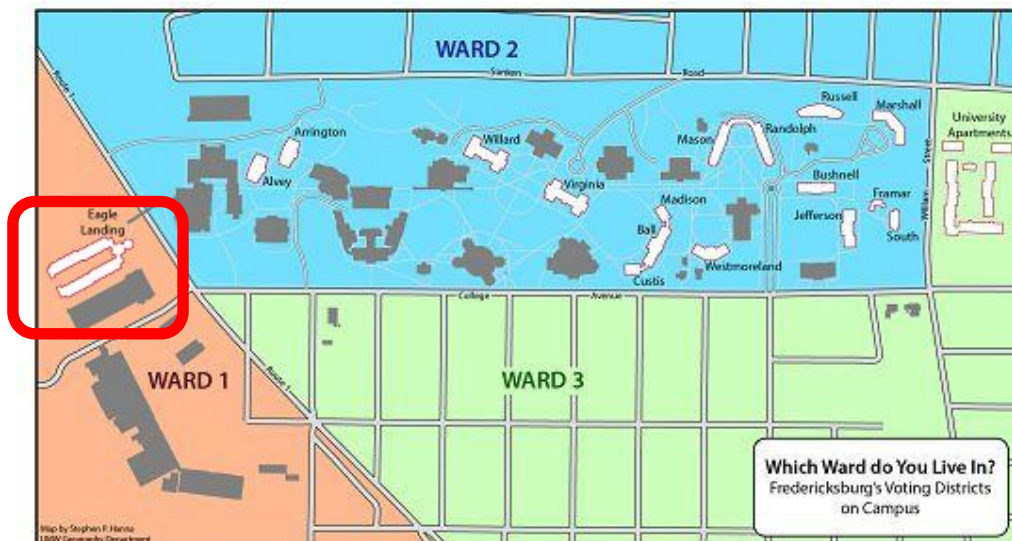


# Registering to Vote: Eagle Village

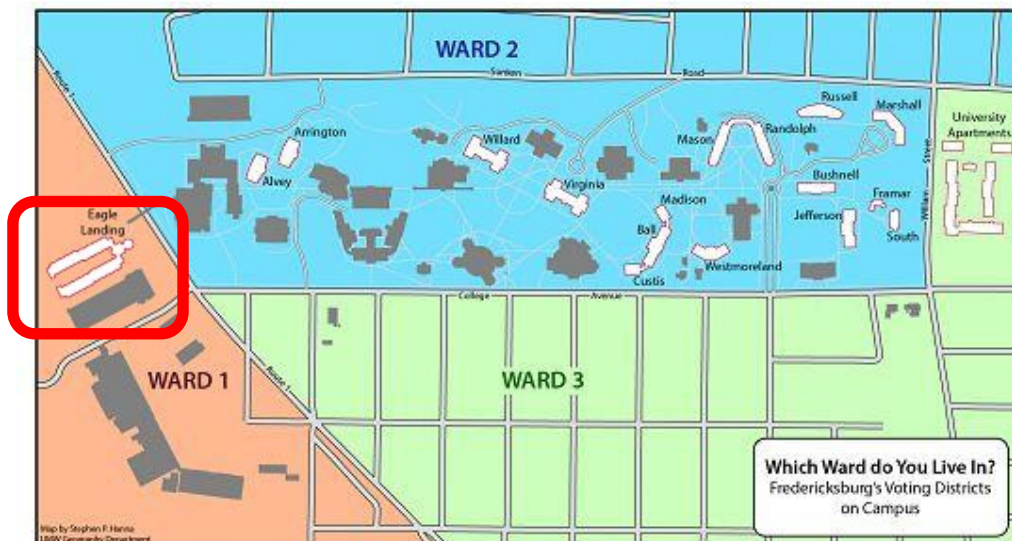
