6. Rationale statement (Why is this additional program needed? What purposes will it serve?)

Proposed change for minor: add several courses to the Group II list.

As the program director for the Practical Ethics Minor, I periodically review both student requests for course substitutions and UMW course offerings to see if any changes should be made to the official list of courses that would satisfy the minor requirements. We wish to make no changes to the minor's core ethics requirements ("Group I" courses), but do want to add a few courses to the more interdisciplinary branch of the minor (the "Group II" courses). Courses in the second group are generally not explicitly about ethics, but rather add to a student's knowledge and understanding of ethics. For example, a student interested in environmental ethics would likely take—in addition to PHIL 335 Environmental Ethics—a class such as HIST 322: U.S. Environmental History.

Although there are many courses at UMW that could work nicely to round out a student's Practical Ethics minor in the way just noted, providing a few more explicitly listed options in the Group II menu will cut down on the number of requests for substitutions I need to make to the Registrar's Office.

The courses we wish to add to the minor's "Group II" list:

Although adding a course to the list might increase the number of student interested in taking the course, there are good reasons for thinking that the number will be insignificant. First, since the list is reasonably long, no single course would likely be sought out by those in this minor. Second, since the list includes courses in a wide array of disciplines, students are likely to opt for those courses in their chosen major (up to two courses are allowed to overlap between a major and minor), which spreads out student interest even more. Finally, since there would be now so many courses listed as options, no faculty would need to feel any pressure to force-add students to a full section to help a student finish the minor.

Requirements for the Practical Ethics Minor

Eighteen (18) credit hours to include a minimum of three courses from the philosophical ethics offerings (Group I), and three additional courses from the remainder of Group I and/or from Group II. At least three of the total courses must be at the 300-400 level.

Students who do research or other work for credit in ethics in any major or field of study – e.g., through URES, independent study, or internship – may use those credits for the minor with approval by the director of the Practical Ethics Minor. Students are strongly encouraged to seek service learning and guided research opportunities, both for credit and non-credit, through the Center for Honor, Leadership, and Service.

Group I: PHIL 160, 225, 226, 330, 335, 430.

Three additional courses taken either from Group I above or from Group II below.

Dear Leslie Martin:

We would like to add **ANTH 211 and 212, and SOCG 404** to the list of options for the Practical Ethics Minor. The minor requires three courses from "Group I," which is a short list of courses explicitly in philosophical ethics (e.g., Medical Ethics, Ethical Theory, and Environmental Ethics), and three courses from either "Group II" or the remaining courses in Group I. Group II is meant to allow students to take ethics-related courses in other disciplines, including their major. These courses generally do not focus on ethics, but rather give students greater depth and background to better understand issues in ethics. For example, a student interested in environmental issues might pick PHIL 330: Environmental Ethics from Group I and one or two of the options from Earth and Environmental Sciences in Group II. It is to Group II that we would like to add your courses.

The number of students taking your courses to satisfy the minor's requirements would likely be low, and in fact, probably unnoticeable. If this proposal for additions is approved, Group II would include more than thirty courses from around the University, minimizing pressure on any one course. There is no evidence that the courses already on the list have faced enrollment pressures due to being part of the minor. Further, we expect that students will continue, where possible, to pick courses that also count in their major, which would mean that they would likely be taking such a course whether or not they were completing this minor.

The Curriculum Committee requires evidence that you support our proposal and have no concerns regarding your departmental resources. If you agree that your courses would be a good fit for the minor and have no objections or concerns, please respond to this email noting your support. We will submit the email exchange with the curriculum application. If you have any questions or would like to discuss this proposal further, please contact me at imatzke@umw.edu. We would be delighted to have your courses as part of this minor.

Hi, Jason,

I agree that WGST 101 (Introduction to Women's Studies) would be a good addition to the Minor in Practical Ethics. As you know, we are not a department, and our program relies on staffing resources from other departments with dedicate faculty lines across campus: their good will, faculty interest, and their own staffing ability to accommodate interdisciplinary curricula.

That said, the pressure on WGST 101 is already high. Based on your analysis I do not expect the PE minor to affect that pressure; in fact, the fact that students request its inclusion is evidence that they take the course because they *want* to and so there is much overlap in student interest in thinking about Practical Ethics and Women's and Gender issues of societal inclusion.

In addition, I would support WGST 102 (Intro to Perspectives in Sexualities) being included in the minor. We also have enrollment pressure on this course, but--again--I do not expect this will be affected much. Indeed, it is a staffing issue already in play.

In sum, I and the WGST advisory board and instructors of these courses support inclusion of WGST101 and 102 in the Practical Ethics Minor. Thank you for recognizing the importance of women's, gender, and sexuality issues for UMW students and for a liberal arts curriculum, and let me know if I can be of further support.
