Comment on the strengths and weaknesses of the existing print and electronic collections.

We evaluated our collection of Arabic language and literature materials using *Resources for College Libraries*, a collection development tool that contains core title lists of print and electronic materials that are essential for undergraduate study. We found that the Libraries own less than 15% of the 606 titles on the Arabic Language and Literature list. Our current collection consists mainly of language dictionaries and grammar guides and is especially weak in the area of Arabic literature. We request \$2000 to build a core collection. We also request \$750 in ongoing funds to acquire new titles each year. Based on data from our monograph vendor, we estimate that 30-40 new titles are published each year; these ongoing funds will enable us to select relevant new titles to keep the collection current.

Rationale Statement Minor in Arabic Studies

By all accounts in both the public and private sectors, the demand for individuals who are fluent in Arabic is rising, and will continue to rise throughout the decades. Arabic is the 5th most commonly spoken native language in the world. There is a high demand for and low supply of Arabic – speakers in the western world, with the growing importance of the Middle East in international affairs. Those who study Arabic can find careers in a variety of fields, including Journalism, business and industry, education, finance and banking, translation and interpretation, Foreign Service and intelligence.

For a number of years, the Department of Modern Languages and Literatures has been offering courses in Arabic as one of other 5 languages. Numbers of students have requested that the department offer more advanced Arabic classes and develop a minor. Our Arabic program has been growing with 50 students in the Elementary, and around 24 in Intermediate, and 9 -10 in Advanced, however the advanced level vary every semester based on the students interest and needs especially finishing their elective credits. The goal of the minor will give the students the opportunity to continue beyond the language requirement and will encourage the students to continue learning Arabic. The second goal of the minor will be to improve students' proficiency in reading, writing, speaking and understanding spoken Modern Standard Arabic and a deeper understanding of the culture, religious, political and historical aspects of the Arabic speaking world. Third, the minor will increase their careers options by providing them with the language skills necessary to interact more effectively with Arabic speakers.

In accord with the Department's Student Learning Objectives, Arabic minor will learn to:

- Identify key figures, historical events, and concepts in language, literature, religion, mythology, science, politics, drama, art in Arabic speaking world.
- Interpret, analyze, and compare significant works from Arabic cultures.
- Develop the ability to read, write, and speak in Modern Standard Arabic proficiency to advanced level.
- Show an understanding of cultural diversity by comparing the values and practices of the Arabic cultures to their own.
- Effectively research and write expository or argumentative papers in Arabic.

The proposed minor would require 18 credits above the elementary level, and the Sequence for Arabic is as follow:

Required (12 credits) ARAB 201: Intermediate Arabic (3) ARAB 202: Intermediate Arabic (3) ARAB 301: Advanced Arabic (3) ARAB 302: Advanced Arabic (3)

Native or heritage speakers or any student who places above the 202 level will be required to take 2 additional elective courses.

There will be no competition among programs for students or resources. Also will be no duplication of courses.

Budgetary and staff Implications:

There is now one full- time faculty member teaching Arabic. As the program grows, we may need to add one adjunct instructor, staffed by a Visiting Language Instructor form abroad, to pick up one or two sections of beginning Language per year.

Course description in the catalog:

The minor in Arabic Studies is designed for students who wish to develop their Arabic Advanced language proficiency and broaden their knowledge of Arabic literatures, history, politics, and culture. Completion of the minor requires 18 credits in applicable courses. Required courses (12 credits)

include: ARAB 201, 202, 301, and 302. Native or heritage speakers or any student who places above the 202 level will be required to take 2 additional elective courses. Electives courses (6-12 credits) include: ARAB 310, ARAB 351, ARAB 352, ARAB 491, ARAB 492, RELG 210, HIST 383 and GEOG304.
