



Chicago Style: Notes-Bibliography (17th ed.) Non-Written Unconventional Sources

General Guidelines

- Chicago is organized into two separate styles: Notes-Bibliography and Author-Date. Notes-Bibliography (NB) is by far the more commonly used style. If your professor only specifies Chicago, it is safe to assume they mean Notes-Bibliography.
- Notes-Bibliography uses footnotes and endnotes instead of traditional in-text citations. Your professor will usually specify whether they prefer footnotes or endnotes. If your professor does not specify, you can usually use footnotes.
- There are two citation formats for every source: one that is used on the bibliography page and one that is used in footnotes or endnotes. These are similar but not identical.

Bibliography

- The bibliography page should begin at the top of a new page.
- The bibliography page should be labeled “Bibliography,” not “References” or “Works Cited.” It should be the same font size as the rest of your paper. It should not be placed in quotes, italicized, or bolded, but it should be centered on the page.
- Leave two blank lines (single-spaced) between the label “Bibliography” and your first bibliography entry.
- Your bibliography entries themselves should be single-spaced, but there should be one blank line (single-spaced) left between entries.
- Entries should be alphabetized by the first word of the entry.

Notes

- Footnotes appear at the end of each page. Endnotes appear immediately after the body of the paper but before the bibliography page.
- Notes should be numbered with Arabic numerals in order of occurrence throughout the text.
- Within the text, notes should be superscripted and placed at the end of the sentence to which it refers. Superscripts should always be placed after punctuation marks.
- Notes themselves should be single-spaced, indented by half an inch, and begin with a normal-text Arabic numeral followed by a period.
- The first time you cite a source, you should use the full footnote citation. If you cite the same source again in your paper, you may use the shortened footnote.

SWC [1]: Note that while bibliography entries use a hanging indent, footnotes use a standard first-line indent, not a hanging indent.

SWC [2]: Note that “Ibid.” is no longer used in the most recent version of Chicago

SWC [3]: Chicago tends to assume that if you are referencing an image, you have included it as a figure in the body of your paper. The image should have a caption below that includes the bibliographic information for the image. The example below demonstrates how that caption should be formatted. Images included in the body of the paper do not need to be cited in the notes or bibliography. When referring to the image in the text, you should use a parenthetical citation at the end of the sentence that references the figure number. For example, (fig. 1).

SWC [4]: Here, you should list the figure number followed by a comma.

SWC [5]: Here, you should list the name of the artist in last name, first name format.

SWC [6]: Here, you should list the title of the artwork, formatted in quotation marks. It should be followed by a comma.

SWC [7]: Here, you should list the medium of the work, followed by a comma. Note that it should be capitalized.

SWC [8]: Here, you should list the date the artwork was created followed by a comma.

SWC [9]: Here, you should list the location or owner of the physical artwork that has been reproduced followed by a comma.

SWC [10]: Note that the word "In" comes before the title of the work in which the artwork is reproduced. Note that it should be capitalized.

SWC [11]: The title of the work in which the artwork is reproduced should be italicized and followed by a comma.

SWC [12]: Here, you should list the primary contributor of the print work. In most cases, this will be the author, in which case you would use "by" instead of "edited by." However, because the example source used was an edited collection without a primary author, the editor was cited here instead.

SWC [13]: Here, you should list either the page number on which the artwork appears or the figure number or plate number of the artwork in the print

SWC [14]: Here, you should include the place of publication of the print source. Normally, this would be a city and state (ex. Fredericksburg, VA), but the example source provided no location information other than the country. The location should be followed by a colon.

SWC [15]: Here, you should list the publisher of the print source, followed by a comma.

SWC [16]: Note that when an artwork is reproduced on the web, the title of the artwork is formatted in italics.

SWC [17]: Here, you should list the location of the physical artwork followed by a comma.

SWC [18]: Here, you should include the URL of the website where the artwork is housed. Make sure to remove the hyperlink from the URL. URLs should not appear blue or underlined.

SWC [19]: In the notes, the artist's name should be in first name last name format and followed by a comma.

SWC [20]: The title of the artwork should be italicized and followed by a comma.

SWC [21]: Depending on the type of artwork, your date may be a range of years, an approximate date, a year, or a specific date. An approximate date should be indicated using the abbreviation ca. for circa. You should use as specific information as you have. In the notes, the date should be followed by a comma.

SWC [22]: Here, you should list the medium of the artwork. Note that in the notes, it is not capitalized.

SWC [23]: Here, you should list the dimensions of the artwork. For three dimensional artwork, you should also include the dimension for depth. You should first list the dimensions in whatever units are given by the source. Then, you should convert into either metric (centimeters/meters) or imperial (inches/feet) and list those dimensions in parentheses.

SWC [24]: In the notes, a comma should follow the parentheses.

SWC [25]: Here, you should list the location where the artwork is housed.

SWC [26]: If images of the piece are available online, you should include a URL at the end of your citation. If there is no online image of the piece, you may omit this.

SWC [27]: Note that the shortened note should use the artist's last name followed by a comma.

SWC [28]: If the title of the work is more than four words, you should use a shortened version of the title here.

SWC [29]: In the bibliography entry, the artist's name should be in last name, first name format and followed by a period.

SWC [30]: In the bibliography entry, the title should be followed by a period.

SWC [31]: In the bibliography entry, the date should be followed by a period.

SWC [32]: Note that in the bibliography entry, the medium should be capitalized. The medium should be followed by a comma.

SWC [33]: In the notes, the title of the film is listed first. It should be formatted in italics and followed by a comma.

SWC [34]: In the notes, the director should be listed second. The phrase "directed by" should precede the director's name, which should be formatted in first name last name format.

SWC [35]: In the notes, the publisher and date should be in parentheses, separated by a comma.

SWC [36]: Here, you should include the medium you used to access the film.

SWC [37]: The shortened footnote should only include the title of the film.

SWC [38]: You should start with the director of the movie, writing their Last Name, then their First Name, then writing out "director."

SWC [39]: Next, you will write the name of the film in italics.

SWC [40]: Publication Location

SWC [41]: This is where you will put the name of the studio that made the film.

SWC [42]: Here is the year of the movie's release.

SWC [43]: In the notes, the TV show's name should be in italics and followed by a comma.

SWC [44]: The episode name is in quotation marks and followed by a comma.

SWC [45]: In the bibliographic entry, the TV show's name should be in italics and followed by a period.

SWC [46]: In this slot, you should put the main person or organization responsible for the content of the video. In this example, the video is a conversation between two art historians, so they are credited here in the "author" slot.

SWC [47]: The title of the video would be in quotation marks and followed by a comma.

SWC [48]: Here, you should include the publisher of the video.

SWC [49]: The date should be formatted in month day, year format and followed by a comma. The month should be written out, not abbreviated.

SWC [50]: The word "video" should appear here in the "medium" slot. It should be lowercase and followed by a comma.

SWC [51]: Note that Chicago does not require you to use the specific time stamp of the part of the video you are referencing in the notes. Rather, you should list the full runtime of the video followed by a comma.

SWC [52]: The shortened note should include the last name or names of the person or people responsible for creating the video followed by a comma.

SWC [53]: The shortened note should include a shortened version of the title formatted in quotation marks.

SWC [54]: When listing multiple authors in the bibliography, the first author's name should be formatted in last name, first name format and followed by a comma. The second author's name should be formatted in first name last name format and followed by a comma.

SWC [55]: Note that "video" is capitalized in the bibliography entry, but it is still followed by a comma, like in the notes.



Music:

SWC [56]: This is denoted because there are multiple songwriters for this song, so it is necessary to specify what kind of contributor this person is. If the vocalist and songwriter are the same, you may omit this.

SWC [57]: The title of the song should be formatted in quotation marks and followed by a comma.

SWC [58]: Here, you should list the songwriters of the song if they are different from the vocalist. If the vocalist and the songwriter are the same person, you may omit this. In this example, Taylor Swift is listed twice because she is both the vocalist and one of the songwriters.

SWC [59]: Chicago privileges the date the actual recording was made over the date of release. If you are unsure of an exact recording date, you can use the abbreviation "ca." for "circa" to indicate an approximate date.

SWC [60]: Here, you should list the track number of the song on the album on which it appears. If the song was a single or not part of an album, you may omit this section.

SWC [61]: Here, you should list the title of the album, formatted in italics and followed by a comma.

SWC [62]: Here, you should list the name of the recording company or publisher followed by a comma.

SWC [63]: Here, you should include the date of release. If the date of release is the same as the date of recording, you may omit the date of release.

SWC [64]: Here, you should list the medium through which you listened to the recording.

SWC [65]: In the shortened note, only the last name of the vocalist is needed.

SWC [66]: The shortened note should include the title of the song in quotation marks.

SWC [67]: In the bibliography entry, the song title should be followed by a period.

SWC [68]: In the bibliography entry, "By" should be capitalized.

SWC [69]: In the bibliography entry, the names of the songwriters should be followed by a period.

SWC [70]: In the bibliography entry, "Recorded" should be capitalized.

SWC [71]: In the bibliography entry, the recording date should be followed by a period.

SWC [72]: In the bibliography entry, "Track" should be capitalized.

SWC [73]: In the bibliography entry, the album name should be followed by a period.

SWC [74]: The title of the speech should be formatted in quotation marks and followed by a comma.

SWC [75]: Here, you should include the date the speech was given in month day, year format followed by a comma.

SWC [76]: Here, you should include the location where the speech was given followed by a comma.

SWC [77]: Here, you should include the medium (file type used to listen to the song) followed by a comma.

SWC [78]: Here, you should include the runtime of the video followed by a comma.

SWC [79]: Here, you should include the URL where the recording can be found.

SWC [80]: The shortened note should include only the last name of the speaker followed by a comma and the title of the speech in quotation marks.

SWC [81]: In the bibliography entry, the speaker's name should be formatted in last name, first name format.

SWC [82]: In the bibliography entry, the title of the speech should be followed by a period.

SWC [83]: In the bibliography entry, the date should be followed by a period.

SWC [84]: In the bibliography entry, the location should be followed by a period.

SWC [85]: In the bibliography entry, the run-time should be followed by a period.

SWC [86]: In the notes, the author's name should be formatted in first name last name format and followed by a comma.

SWC [87]: The title of the book should be italicized.

SWC [88]: Here, you should include the phrase "read by" and the name of the narrator. If the audiobook was read by the author, you should use the phrase "read by the author" instead of listing the author's name twice.

SWC [89]: Here, you should include the city and state of publication followed by a colon. Note that this references the publication information of the audiobook, not the print edition. You may have to look up the publisher to find the location of their headquarters.

SWC [90]: Here, you should include the name of the publisher of the audiobook followed by a comma.

SWC [91]: Here, you should list the date of publication of the audiobook.

SWC [92]: The place of publication, publisher, and date of publication should be placed in parentheses.

SWC [93]: Here, you should include the total runtime of the podcast. The time should be formatted using the abbreviations "hr." and "min." Also note that a comma follows the "hr." abbreviation.

SWC [94]: If the title is longer than 4 words, you should use a shortened version of the title in the shortened note.

SWC [95]: In the bibliography entry, the author's name should be formatted in last name, first name format and followed by a period.

SWC [96]: In the bibliography entry, "Read" should be capitalized.

SWC [97]: In the bibliography, this information is not in parentheses.

SWC [98]: The host of the podcast is listed in the author slot. Note that the host of the podcast used for this example goes by only one name instead of a traditional first and last name. For hosts with a first and last name, the name should be formatted in first name last name format in the notes.

SWC [99]: Should only include the episode in the title if it is included in the title of the episode.

SWC [100]: In the notes, the date is listed directly after the title of the podcast.

SWC [101]: In the notes, the title of the podcast follows the date and should be preceded by the word "in."

SWC [102]: In the notes, the producer follows the title of the podcast.

SWC [103]: Here, you should include the word "podcast"

SWC [104]: The shortened note uses a shortened form of the title.

SWC [105]: For hosts with a first and last name, the name should be formatted in last name, first name format in the bibliography entry.

SWC [106]: In the bibliography entry, the producer information should come directly after the title and should be followed by a period.

SWC [107]: In the bibliography entry, the title of the series should come after the producer information and should be followed by a period.

SWC [108]: In the bibliography entry, the date should follow the title of the series and should be followed by a period.

SWC [109]: Note that "Podcast" should be capitalized in the bibliography entry.

SWC [110]: Because live performances cannot be consulted after the fact by a reader, they do not need to be included in the bibliography, but they should still be cited in the notes. This format can be used for a range of different performances, from plays to music festivals.

SWC [111]: The title of the performance should be formatted in italics and followed by a comma.

SWC [112]: Here, you should list the relevant contributors. This will vary widely based on the focus of your paper. If you are focusing on the play as a whole, you might cite the writer and director, as in the example. If you are focusing on set design, you should cite the set designer. For a musical performance, you should cite relevant performing artists. Each contributor should be preceded by a brief description of their role and separated by a comma.

SWC [113]: Here, you should list the name of the venue where the event took place.

SWC [114]: Here, you should list the location of the venue.

SWC [115]: Unpublished interviews do not need to be included in the bibliography entry. They are typically only cited in text or in the notes. If there is a transcript or recording available somewhere, then you should also include information as to where that transcript or recording can be found in your citation.

SWC [116]: The name of the individual being interviewed should be listed first in first name last name format.

SWC [117]: The information included in parentheses should make clear how the interviewed individual is a relevant source given the content of your paper. This may vary, and does not always have to be the individual's occupation.

SWC [118]: You should include this phrase if you conducted the interview yourself.

SWC [119]: For unpublished interviews that are part of archives or can otherwise be accessed, you should include information on where the interview and/or transcript can be accessed. In this case, the "location" is as simple as a URL, but you could also describe the location within a physical archive if the interview is not available on the web.

SWC [120]: This format refers to interviews published in print.

SWC [121]: Here, you should list the name of the person being interviewed in first name last name format.

SWC [122]: In the notes, the title of the interview should be formatted in quotation marks and followed by a period.

SWC [123]: In the notes, the phrase "interview by" should precede the name of the person conducting the interview.

SWC [124]: Here, you should include the name of the person conducting the interview.

SWC [125]: In the notes, the name of the magazine, journal, or publication should be italicized.

SWC [126]: Here, you should include the issue number of the publication preceded by the abbreviation "no."

SWC [127]: If the publication lists a season or seasons with the year, you should include that information here as well. For example, (Spring 2017) or (Winter/Spring 2017). The parentheses should be followed by a colon.

SWC [128]: Here, you should include the specific page number of the piece of the interview you are referencing.

SWC [129]: In the bibliography entry, the name of the person being interviewed should be formatted in lastname,firstname format.

SWC [130]: In the bibliography entry, the title should be formatted in quotations and followed by a period.

SWC [131]: The bibliography entry uses the word "By" instead of the phrase "interview by." Note that "By" should be capitalized.

SWC [132]: In the bibliography entry, the interviewer's name should be followed by a period.

SWC [133]: The interview used in this example took up only one page. However, for longer interviews, you should the full page range in the bibliography entry.

SWC [134]: This format refers to interviews conducted and broadcast on radio or television.

SWC [135]: Here, you should include the name of the person being interviewed in first name last name format followed by a comma.

SWC [136]: Here, you should include the phrase "interview by" followed by the name of the person conducting the interview in first name last name format.

SWC [137]: The name of the program on which the interview appeared should be italicized.

SWC [138]: Here, you should include the name of the publisher of the program in plain text.

SWC [139]: Here, you should include the date the interview was broadcast.

SWC [140]: In the bibliography entry, the name of the person being interviewed should be formatted in last name, first name format.

SWC [141]: Note that in the bibliography entry, the name of the program comes before the name of the interviewer.

SWC [142]: In the bibliography entry, the phrase "By" is used instead of "interview by" to denote the name of the person conducting the interview. Also, note that "By" is capitalized.

SWC [143]: Personal communications are usually only cited in the text or in the notes. They do not need to be included in the bibliography.

SWC [144]: Here, you should list the name of the person you communicated with in first name last name format.

SWC [145]: Here, you should describe the method/medium of communication.
