



## SHA (Society for Historical Archaeology) References Guide

SHA is a citation style associated with the Society for Historical Archaeology's publishing guide. The SHA style is used primarily in the field of archaeology and in the archaeology courses taught in the Historic Preservation department at UMW.

### General Format for a Reference Entry

In SHA style, your bibliography section should be titled "References" without bolding or italics. The References title should be aligned with the left margin of the page without any indentation or centering. Reference entries are all single-spaced, and aligned to the left.

#### Book (print):

**Author Name:** For all types of sources, the author's name is formatted  
as:

Last Name, First Name, Middle Initial.

#### Chapter in an Edited/Compiled Book:

**Speaking and Writing Center [1]:** Author's name

**Speaking and Writing Center [2]:** After the author's name, the rest of the bibliographic information is listed on a new line. No hanging indents; everything is justified left. After the date, press tab or space over five spaces.

**Speaking and Writing Center [3]:** Source title

**Speaking and Writing Center [4]:** After the source title, include the publishing information. First, state the publishing company or institution, and then the location of the publisher with both city and state. End the publisher information with a period.

**Speaking and Writing Center [5]:** Note that SHA style includes the state's initials as part of the reference.

**Speaking and Writing Center [6]:** Is there always a middle initial? Or is this include it if the author publishes with a middle initial?

**Speaking and Writing Center [7]:** Only include middle initial if the author publishes with their middle name/initial listed.

**Speaking and Writing Center [8]:** Note that the chapter title is not italicized. The title of the container (the book) is italicized.

**Speaking and Writing Center [9]:** Note the format for listing multiple editors. Their names are listed in first name, last name format, followed by a comma and "editors". Note that "pp." is used before the listing of inclusive pages of the chapter.

**Speaking and Writing Center [10]:** Note that the article title is not italicized. Remember, SHA does not use quotations for titles either.

**Speaking and Writing Center [11]:** Note that the journal title is italicized, as journals are considered containers.



### Book or Item in a Book with More than One Author:

For a source with more than one author, list all authors associated with the publication in the reference entry. Only the first author's name should be listed in the above inverted format; all other authors' names will be listed first name last name.

### Electronic Sources

If an electronic book or article is used, follow the same citation style listed above, but include the URL to the resource as the last piece of information at the end.

**Speaking and Writing Center [12]:** Only the first author's last name is listed in the inverted format.

**Speaking and Writing Center [13]:** All other authors' names are listed first name, middle initial, last name.

**Speaking and Writing Center [14]:** Remember to start a new line (justified left) for the rest of the citation information after the authors' names. The date always goes directly underneath the author's name. Again, everything is justified left. After the date, space over 5 times or tab before the rest of the citation. This is particular to SHA.

**Speaking and Writing Center [15]:** Titles of articles, essays, or chapters-- texts that are part of a larger whole-- are written plain text.

**Speaking and Writing Center [16]:** Container works such as books and journals are italicized. The titles of other published works such as published dissertations should also be put in italics. Notice that because this is the name of the anthology in which the chapter appears, the word "In" appears before the title.

**Speaking and Writing Center [17]:** Doctoral dissertations are typically considered published sources but when using a thesis or dissertation, you need to note the kind of source.

**Speaking and Writing Center [18]:** The publishing organization or institution name is used as the author name because the page being cited has no specific/identified author. If the website name is the same as the publisher name, it does not need to be repeated in the reference.

**Speaking and Writing Center [19]:** This is the name of the webpage that is being cited.

**Speaking and Writing Center [20]:** The URL should be formatted between these types of brackets: <>

**Speaking and Writing Center [21]:** Use the date that you accessed the page. Notice that the date is formatted with the day first and the month is written out in full.
