Rationale (Why is this program change needed? What purposes will it serve?)

To ensure the UMW liberal arts mission is continued in the BSN Completion (BSN-C) Program, ENGL 308 *Writing Studies and Healing* was created by the English, Linguistics, and Communication (ELC) Department. BSN-C students are required to take ENGL 308 in their first semester of the BSN-C Program to increase their knowledge and skills in speaking, writing and critical thinking. A non-traditional, working, student population requires courses in the BSN-C program to be delivered online. At this time there is one ENGL adjunct professor who has approval to teach ENGL 308 online. An ELC does have a new faculty member who will be developing an online version of ENGL 308.

The BSN-C Program cohort size in fall 2014 was 11. The fall 2017 cohort was over 30. The growth of the program is expected to continue. It is an unrealistic expectation for the ELC department to offer *multiple* sections each semester of ENGL 308 to BSN students. Not having the additional learning experiences in speaking, writing and critical thinking prior to beginning the NURS sequence, will threaten student success in meeting the liberal arts mission of the university. Thus, threaten the BSN-C Program's accreditation status. In August 2017, the director of the BSN-C Program and the Dean of the College of Arts and Sciences discussed exploring alternative methods for the BSN-C Program to meet the liberal arts mission 2017.

ENGL 308 is NOT being replaced. The proposed program change allows the growth of the BSN-C program to continue, and generate additional revenue for the university. The program change will be administered by the BSN Completion Program and the newly proposed course will be taught by a nurse with a graduate or terminal degree in nursing. The addition of a proposed course will generate additional tuition revenue, which will cover the cost of an adjunct nursing faculty member. This program change does not require additional space. The library resources to BSN Completion and other undergraduate students are sufficient. The program change will have a positive impact on the ELC Department by minimizing the burden of the BSN Completion needs as the program grows.
